



## 2023 Kentucky Derby Festival Louisville Muhammad Ali International Airport VIP/Upgraded Seats Thunder Experience Giveaway Official Terms & Conditions

**1. Eligibility:** Sweepstakes is open only to those who sign up at the online sweepstakes page and who are 21 or older as of the date of entry. The sweepstakes is only open to legal residents of The United States and is void where prohibited by law. Employees of Kentucky Derby Festival, their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes.
